Dear Speaker Johnson, Minority Leader Jeffries, Majority Leader Schumer, and Minority Leader McConnell:

America's children and families deserve our support. Last year's historic *Dobbs v. Jackson Women's Health* decision by the Supreme Court cleared the way for greater protections for millions of unborn children and their mothers. As pro-life organizations who have long advocated for such a decision, we understand that the work of upholding the sanctity and dignity of life is far from over. Many mothers face significant health and financial challenges throughout pregnancy and into the early years of raising a child. We can, and should, do more as a nation to provide for their needs.

Parents from all walks of life are keenly aware of the financial challenges associated with raising a child. In 2022, the estimated cost of raising a child through the age of 17 was over \$300,000.<sup>1</sup> According to one recent poll, around 50 percent of parenting-age adults wish they had more children than they do.<sup>2</sup> When the New York Times asked parents in 2018 why they are having less children than their ideal number, a majority said childcare was too expensive, with around 44 percent simply saying they can't afford more children.<sup>3</sup> Inflation has only exacerbated these challenges, leaving many parents in a daunting position, even as they courageously prepare to bring a new child into the world.

In our polarized times, few policy priorities both enjoy bipartisan agreement and promise to make a significant difference in the lives of millions of American children and their families. The CTC expansion is such a policy. We ask for your attention and prioritization of this important matter.
